My vision is more active involvement of every Board member in growing NAEFO. And engaging others to join us and support actions that achieve our goals of education and addressing the needs of emergency response organizations. Increased visibility of NAEFO at events, letter writing, presenters, connect with lawmakers for change and/or continued funding for critical programs and laws.

Would love to hire out some of the necessary tasks to an associated management firm. However, I feel the Board needs to determine the priorities to be successful.

Perhaps a Strategic Planning meeting in the near future? We need sponsorships, membership drive and overall, more exposure of NAEFO activities and calls to action. We need a consistent social media presence, recruiters for interesting presenters for webinars and conferences.
